The ITSAGROPUGLIA strategy incorporates the GLOCAL (think globally, act locally) philosophy. The global market is the place where to promote and sell traditional, Made in Italy agri-food products, that result from the craftsmanship skills handed down for generations. Italy's Puglia region, in fact, is very rich in traditional and quality agri-food products, although local sales have been sluggish due to the continued economic recession. The global market is seen as the place where to promote the Mediterranean Diet (UNESCO intangible heritage) and associated products and where to exchange skills and technology relevant to Agri-food Companies and their innovation objectives.

The ITSAGROPUGLIA internationalization strategy is a seven-year plan and will be considerably enhanced by the participation to:

Erasmus Key Action 1 (KA1) - mobility of students and staff

The number of study and traineeship opportunities for incoming and outgoing students (EU Programme Countries) will be increased and will raise the international spirit of the participants. Similarly, international agreements will be signed with non-EU Institutes, Universities, Companies and other entities related to the Made in Italy agri-food products, within the International Credit Mobility programme.

Erasmus Key Action 2 (KA2) - Cooperation among organizations and institutions

ITSAGROPUGLIA, as a member of the Chain5 Association, is in the process of identifying similar thirdlevel educational institutions which are willing to collaborate. Exchange agreements will be prepared and signed, while collaboration will include vocational and technical education best practices: detection of training needs, course design, traineeship management, monitoring procedures and digital transformation. Participation in the *Partnerships for Innovation* projects will focus on the development of *Industry 4.0* projects and on the knowledge transfer to relevant companies in the agri-food industry. The European Commission's EIP AGRI Projects can support innovation within the Erasmus + projects.

The National Reference Professions defined by MIUR for each sector are published on the Official website of the Foundation. Each year, in relation to specific skills and technology applications required by employment and professions (training needs), ITSAGROPUGLIA designs specific programmes that are

recognised at national level at local level. The language of the lessons is primarily Italian; there are lessons for the consolidation of English and technical subjects taught partly or completely in English.

Calls will be published on the official ITSAGROPUGLIA website www.itsagroalimentarepuglia.it and social media pages. The evaluation of candidates will be based on: average grades (theory and practice); language skills (English or the official language of the chosen country); relevance of the project proposal; personal motivation. Erasmus activities will be managed by a dedicated staff member with previous experience in international environments.

An Erasmus Committee, appointed by the Executive Board of ITSAGROPUGLIA, will select the eligible candidates according to the criteria set out in the call. Traineeship tutors / scientific tutors (TSS) are appointed by ITSAGROPUGLIA and are in charge of organising and monitoring the LA and the activity calendar. They also ensure effective communication among students, hosting institutes and company tutors. TSS work remotely, but can visit the relevant company or country if needed. For the management of staff mobility, standard procedures will be implemented and clear conditions of service will be set out.

ITSAGROPUGLIA adopts a Quality Management System compliant with UNI EN ISO 9001: 2015 which allows to manage processes in a standardised manner and to perform a continuous monitoring that will generate a continuous improvement. In addition, the UNI EN ISO 29990: 2011 certification is adopted for the design and provision of specialised postgraduate technical training courses and the transfer and dissemination of scientific and technological culture in the agri-food sector.

ITSAGROPUGLIA, thanks to the Erasmus+ 2021-27 programme, aims to enhance and diversify the internationalization of the institute.

- Improve, through the expansion of the horizon of reference, the level of qualification of ITSAGROPUGLIA courses to allow the formation of specialized technicians on the basis of the training needs of the productive sector and international food scene;
- Improve the quality and value of higher education, attracting a greater number of students, reducing the early school leaving, boosting employability and entrepreneurship and thus allowing the formation and entry into the working world of the professionals required by the specialised world of work;

- Strengthen the links between training sectors and the productive ones to foster excellence and regional development, improving the links between fundamental research and applied research

- Improve the governance and financing through the search for complementary funding sources both public and private, identifying the real costs and directing the expenses with the help of systems and evaluation of the results of stress concentration on specific priority areas.

ITSAGROPUGLIA operates according to the principles of non-discrimination and respect of equal opportunities for all.

Student admission to ITSAGROPUGLIA programmes occurs in accordance with the principles of equality and non-discrimination in regard to gender, religion and personal beliefs, race and ethnic origin, disability, age, sexual or political orientation.

In addition, the Foundation guarantees equality between men and women (the basic principle of democracy). ITSAGROPUGLIA is strongly committed to tackle gender-based discrimination, that is particularly severe in Italy: women experience higher rates of unemployment and lower salary levels than their male counterparts.

Women manage over 600,000 agri-food companies and, as a consequence, the agro-food sector ranks third, with 18% female participation, after trade and services.

The data collected by the European Commission in 28 member countries show that women business owners earn on average 6% less than their male colleagues: this gender pay gap also persists at management level and in other employment sectors.

Education and training are key to labour market participation for women, and ITS aims to increase female student enrollment and related job opportunities in partnerships with relevant stakeholders.

The concept of "Equal Opportunities for All" is fully aligned with the spirit of the Italian Constitution,

according to which "everyone should be given equal opportunities" to promote a general "advancement of the whole society".

Every step forward will be not only for those who have done it, but for the whole of society. "Our

differences are our strength" suggests the European Union, "so that citizens can fully benefit from the wealth of skills, talents and ideas, participation and inclusion by all".

ITSAGROPUGLIA activites are based on the principles of equality and non-discrimination and are implemented in the following ways:

- improvement of equal opportunities and participation for people at risk of exclusion, including women;
- improving students' labor market participation by enhancing their skills and employability;
- assist students with learning disabilities;
- provide flexible learning arrangements to promote good work-life balance practices for women and their families;

- encourage the participation in the labor market of those at risk of discrimination, both in the traditional and innovative business sectors with a special focus on female employability;

- promote other actions that increase the work-life balance.

The principles of equality and non-discrimination are considered for all ITSAGROPUGLIA projects and phases. In the selection phase, assessments are based exclusively on professional qualifications, individual skills and motivation; during the training/education phase, steps are taken to ensure the full respect for personal dignity in a discrimination-free environment, the promotion of personal growth and the enhancement of sector-specific and team-work skills.

ITSAGROPUGLIA is committed to tackle gender stereotypes in the agri-food sector while delivering educational content and learning activities aligned with the principles of the Fourth Industrial Revolution (4IR) and compatible with an appropriate work-life balance.

ITSAGROPUGLIA aims to take part in the Online Learning Agreement (OLA), Egracons (Grade Conversion), ESC (European Student card) and EMREX project directly or through the development of specific apps. This transition to electronic data interchange will facilitate collaboration, training, grading and resource sharing on a national and international level.

The goal is to have the initiative operational in 2021. By this time, higher education institutes participating in the coming Erasmus + programme are expected to adopt the Erasmus Without Paper network to exchange student mobility data. The use of the Erasmus Without Paper network will be compulsory.

All students registered to an ITSAGROPUGLIA course will receive the European Student Card and this will create a sense of belonging and community and facilitate their exchange by the following schedule:

2021 - to manage inter-institutional agreements and online learning agreements

2022 - to send and receive student nominations and acceptances

2023 - to exchange transcripts of records related to student mobility

Please explain how your institutions will implement and promote environmentally friendly practices in the context of the Erasmus+ programme.

ITSAGROPUGLIA organises activities and training programmes with the aim to develop optimised agrifood systems, reduce the production of waste and a strong focus on environmental sustainability. Outgoing and incoming students and staff members will be able to learn and transfer environmentally

friendly practices. ITSAGROPUGLIA, is fully committed to adopting practices that would allow the conservation of natural resources, the reduction of greenhouse gas emissions and an increased carbon sequestration. For example, an international research project based in California is evaluating the combined use of sensors and mathematical models for the improvement of fruit trees and field crops' irrigation practises. Other projects are based on the principles of precision agriculture (agriculture 4.0) and aim to optimise or reduce the use of synthetic fertilisers and pesticides. A project based in the Valencian community (Spain) is analysing improved post-harvest technologies applied to fresh fruit and vegetables: increased shelf-life and reduction of food product waste have been reported. Over the next seven years, ITSAGROPUGLIA is committed to digitise paper-based documents and join "Erasmus without paper". Plastic-free gadgets will also be provided to each participant.

Please explain how you will promote civic engagement and active citizenship amongst your outgoing and incoming students before, after and during mobility.

Also considering the European guidelines, ITSAGROPUGLIA promotes the participation and active citizenship of young people, the development of civic, leadership and cooperation skills relevant to civic engagement and important for future employment opportunities in a period where good collaboration practices are always required.

Following the Council of Europe Recommendations, citizenship education in Europe is not included in a specific course, as it is considered a cross-cutting issue that requires multidisciplinary approaches to facilitate the acquisition of the knowledge, attitudes and skills necessary for individuals to live together and in harmony in a democratic and multicultural society. ITSAGROPUGLIA objectives foster the development of the values necessary to become responsible citizens (learning respect, conflict resolution, harmonious coexistence, benefits of equality and diversity in society and in the workplace, self-confidence, etc.).

ITSAGROPUGLIA teaching staff is trained beforehand and is required to adopt teaching methods that encourage the development of critical thinking, the ability to work in a team and many other soft skills that are increasingly required along with the technical ones. Among the objectives of the ITSAGROPUGLIA educational activities there are: the acquisition of the skills necessary for active participation in public life as responsible and critical citizens; the acquisition of social and moral responsibility, including trust in oneself and in others, in order to foster greater mutual understanding; the strengthening of the spirit of solidarity; the construction of values that fully take into account the plurality of points of view within a society - learning to listen and peacefully resolve conflicts; learning to contribute to a safe environment; the development of more effective strategies to combat racism and xenophobia.

ITSAGROPUGLIA activities are focused on the development of theoretical and practical knowledge, but also on developing positive attitudes towards civic engagement and active citizenship.

Outgoing and incoming students are briefed on the objectives of the ERASMUS + Programme: learning how to be European citizens, personal and professional growth, cultural enrichment and learning the importance of equality and diversity. After mobility, ITSAGROPUGLIA encourages the exchange of ideas and information among students, so that they can share their experiences, challenges and achievements.

ITSAGROPUGLIA courses are designed, delivered and assessed by the Foundation and are organised in 4 semesters. The Diploma of Senior Technician released by MIUR at the end of the course, corresponds to the 5th EQF level qualification, which allows access to public competitions, professional practice related to the agri-food sector and university recognition of ECTS.

Italian credits correspond to ECTS: 1 Italian credit (CFU) = 25 working hours = 1 ECTS.

Each semester corresponds to 60 Credits (CF). Each CF is equivalent to 25 hours.

In particular, for lessons in the classroom 1 CF is equivalent to 10 hours of classroom activities + 15 hours of individual study; for practice exercises 1 CF is equivalent to 20 hours + 5 hours of individual study. For the traineeship 1 CF is equivalent to 25 hours of activity.

An "International" section will be created on the ITSAGROPUGLIA official website, where these criteria will be published.
